

USER AGREEMENT

This User Agreement ("Agreement") is between His Divine Grace A C Bhaktivedanta Swami Prabhupada ("His Divine Grace A C Bhaktivedanta Swami Prabhupada"), the Free Software Provider including any intermediaries, and the "User" and/or the "Users." The Agreement covers the His Divine Grace A C Bhaktivedanta Swami Prabhupada and/or other persons and/or organisations with Software from the Software Provider, which may be stored and sent on a CD-ROM, received from electronic mail, or downloaded from Website/s or affiliated Web pages or Servers or from other sources under the terms and conditions set forth below.

The User agrees to the terms and conditions of this Agreement. His Divine Grace A C Bhaktivedanta Swami Prabhupada's intermediaries AGREE AND GRANT RIGHTS TO USER TO MAKE USE THE SOFTWARE COMMISSIONED BY His Divine Grace A C Bhaktivedanta Swami Prabhupada AND THE USER ACKNOWLEDGES THAT THEY HAVE READ THIS AGREEMENT, UNDERSTAND IT, AND AGREE TO BE BOUND BY ITS TERMS AND CONDITIONS.

1. SOFTWARE.

As used in this Agreement, the term "Software" means, collectively: (i) the free software product commissioned by His Divine Grace A C Bhaktivedanta Swami Prabhupada (ii) all the contents of the disk(s), CD-ROM(s), electronic mail and its file attachments, or other media with which this Agreement is provided, including the object code form of the software delivered via a CD-ROM, electronic mail, or Web page (iii) digital images, stock photographs, clip art, or other artistic works ("Stock Files") (iv) related explanatory written materials and any other possible documentation related thereto ("Documentation"); (v) fonts, and (vi) upgrades, modified versions, updates, additions, and copies of the Software (collectively "Updates"), if any under this Agreement. The Software to be used under the name of His Divine Grace A C Bhaktivedanta Swami Prabhupada choosing to which His Divine Grace A C Bhaktivedanta Swami Prabhupada has sole and complete right.

2. TRANSMITTING RIGHTS & USE.

His Divine Grace A C Bhaktivedanta Swami Prabhupada's intermediaries grant to the User the right to use the Software that the User can view or install on their local hard disk(s) or other permanent storage media of one computer or browser and use the Software.

3. LIMITATIONS ON END-USER RIGHTS FOR SOFTWARE.

Users rights are governed by the License/s attached on the accompanying computer files and / or addendum / appendix and / or Web page/s.

Users agree that Users shall only use the Software in a manner that complies with all applicable laws in the jurisdiction in which Users use the Software, including, but not limited to, applicable restrictions concerning copyright and other intellectual property rights.

The User accepts Copyright, Patents and Trademarks.

If the Software supports multiple platforms or languages, if Users receive the Software on multiple media, or if Users otherwise receive multiple copies of the Software, the User ensures that the number of computers on which all versions of the Software are installed shall accept this user agreement. Users rights are governed by the License/s attached on the accompanying computer files and / or addendum / appendix and / or Web page/s.. If the Software is an Update to a previous version of the Software, Users must possess valid end-user rights to such a previous version in order to use the Update, and Users may use the previous version for ninety (90) days after Users receive the Update in order to assist Users in the transition to the Update. After such time Users no longer have a right to use the previous version, except for the sole purpose of enabling Users to install the Update.

6. COMMENCEMENT, TERMINATION & ACKNOWLEDGEMENT.

Users Agreement is effective from the first date the Users install, views or uses the Software. Users may terminate this Agreement at any time. That User rights automatically and immediately terminate without notice if User fail to comply with any provision of this Agreement.
